

## **Kalshi Ideas Community Guidelines**

### **1. Purpose**

The purpose of Kalshi Ideas is to serve the public conversation. Our rules are to ensure all people can participate in the public conversation freely and safely, and in a manner that promotes the integrity of the Kalshi Exchange. By continuing to use this platform, you consent to abide by these guidelines as may be updated from time to time and without notice.

### **2. Monitoring**

Kalshi will monitor Kalshi Ideas and retain the right to limit the use and access to this platform. To enforce these Community Guidelines, Kalshi may in its discretion remove posts from Ideas, warn and inform users about compliance with the Community Guidelines, and/or prohibit users from participating on Ideas. These actions are separate from, and in addition to, actions available under Kalshi's Rulebook.

### **3. No Trading Advice**

This platform is provided for the convenience of Kalshi's members. Kalshi does not provide trading advice. All information provided by Kalshi is for informational purposes only. Trading on Kalshi involves risk and may not be appropriate for all. Members risk losing their cost to enter any transaction, including fees. You should carefully consider whether trading on Kalshi is appropriate for you in light of your investment experience and financial resources. Any trading decisions you make are solely your responsibility and at your own risk. Past performance is not necessarily indicative of future results.

### **4. Acceptable Use**

You may not use this platform for any unlawful purpose or in furtherance of any illegal activity. This includes the rules of Kalshi's Rulebook and all other applicable law.

### **5. Trading Prohibitions**

You may not use this platform for any attempted or actual trading violations as described in Rule 5.13 of Kalshi's Rulebook. This specifically includes:

- 5.1. attempts to form a non-competitive trade;
- 5.2. unnaturally inflate trading volume;
- 5.3. attempts to circumvent Kalshi's order processing, trade ordering, trade execution systems, or otherwise to circumvent exposure of the order to open and competitive bidding on the Exchange;
- 5.4. trading for a Person other than yourself;
- 5.5. engaging in any activity that presents a risk of harm to Kalshi, its Members, or the public;

- 5.6. engaging in any activity that adversely affects the integrity of the Kalshi or its underlying systems;
- 5.7. intentionally provide misleading, erroneous, or fraudulent information;
- 5.8. engaging in any activity that is intended to, or has the effect of, manipulating the market in violation of Sections 6(c) and 9(a)(2) of the CEA;
- 5.9. engaging in any other activity that would violate the CEA or the Commission's Regulations;
- 5.10. making false representations;
- 5.11. engaging in conduct or practices inconsistent with just and equitable principles of trade or conduct or practices detrimental to Kalshi;
- 5.12. Discussing or manipulating material non-public information that is the subject of an Underlying of any Contract;
- 5.13. attempting to exert influence on the subject of an Underlying of any Contract;
- 5.14. Engaging in any activity that constitutes fraudulent or abusive trading, including but not limited to violating bids or offers, demonstrating intentional or reckless disregard for the orderly execution of transactions during the closing period, or spoofing;
- 5.15. Engaging or attempting to engage in any activity intended to accomplish a "money pass", "wash trade" or "front-running" as such terms are defined by the Commission and any regulations promulgated thereunder;
- 5.16. Directly or indirectly, intentionally or recklessly use or employ, or attempt to use or employ, any manipulative device, scheme, or artifice to defraud; make, or attempt to make, any untrue or misleading statement of a material fact or to omit to state a material fact necessary in order to make the statements made not untrue or misleading; or (3) Engage, or attempt to engage, in any act, practice, or course of business, which operates or would operate as a fraud or deceit upon any Person; or
- 5.17. any other illegitimate purpose.

## **6. Participation Guidelines**

Participating on Kalshi Ideas includes the ability to make a new post, comment on an existing post, and react to an existing post or comment, pursuant to the following guidelines:

- 6.1. In order to participate on Kalshi Ideas, a person must either be a member of the Kalshi Exchange or an applicant for membership on the Kalshi Exchange. To be considered an applicant for membership on the Kalshi Exchange, a person must have created an application by signing in with their Google account or submitting a valid email address and phone number as well as creating a password.
- 6.2. Any member of the Kalshi Exchange or applicant for membership on the Kalshi Exchange may comment or react to an existing post or comment.

- 6.3. A member may make a new post in any market that she has either an open position or a return. Member posts in a given market will include an indication of the direction of the member's position or return in that market.
- 6.4. Kalshi may also allow a person to post regardless of whether she has an open position or a return in the relevant market. In that case, the post will include an indication as to which direction of the market the post is about.

## 7. Other Guidelines

Use of this platform is conditioned upon the following;

- 7.1. Be respectful. This means no mean, rude, hateful, or harassing comments. Treat others the way you want to be treated.
- 7.2. No inappropriate language. Use of profanity should be kept to a reasonable minimum. Any derogatory language towards any user is prohibited.
- 7.3. No pornographic/adult/other NSFW material.
- 7.4. No advertisements.
- 7.5. No offensive names and profile pictures. Keep your names and profile picture appropriate.
- 7.6. Threats are forbidden.

## 8. Safety

You may not threaten, incite, glorify, or express desire for violence or harm. You may not affiliate with or promote the activities of violent and hateful entities. You may not promote or encourage suicide or self-harm. You may not share abusive content, engage in the targeted harassment of someone, or incite other people to do so. You may not attack other people on the basis of race, ethnicity, national origin, caste, sexual orientation, gender, gender identity, religious affiliation, age, disability, or serious disease.

## 9. Privacy

**Private Information.** You may not publish or post, or threaten to publish or post, other people's private information without their express authorization and permission.

**Account Compromise.** You may not use or attempt to use credentials, passwords, tokens, keys, cookies or other data to log into or otherwise access, add, delete or modify the private information or account features of any account other than your own.
