

CRICKETENTITYSTAT

Scope: These rules shall apply to this contract.

Underlying: The Underlying for this Contract is the official attribution of <stat> in <time period> of <cricket match>. For player-specific markets, only statistics officially credited to the specified player count. For team-specific markets, only statistics accumulated by the specified team count. For match totals, statistics from both teams are combined. Statistics recorded during regulation play, Super Overs, and any additional play required to determine a result shall count toward the Underlying, unless <time period> specifies otherwise. Revisions to the Underlying made after Expiration will not be accounted for in determining the Expiration Value.

Source Agency: The Source Agencies are, in hierarchical order, the International Cricket Council (ICC), ESPNcricinfo, the governing board of the relevant competition or <cricket match> (such as the Board of Control for Cricket in India Cricket Australia, or the England and Wales Cricket Board), and the official broadcast partner of <cricket match>.

Type: The type of Contract is an Event Contract.

Issuance: After the initial Contract, Contract iterations will be listed on an as-needed basis at the discretion of the Exchange and corresponding to the risk management needs of Members.

<entity>: <entity> refers to either a cricket team or a cricket player officially entered in a <cricket match> as recognized by the governing body of the competition (e.g., ICC, national cricket boards, or franchise leagues) and specified by the Exchange. If <entity> is a team, it is defined by the national side, franchise, or representative team name as listed on the official fixture schedule, and shall be tracked through official name changes, rebranding, or franchise relocations. If <entity> is a player, it is defined by the athlete's full name as listed on the official squad or match-day playing XI of the governing body, with the full name governing where two or more players share the same surname. <entity> may also be referred to in the singular or plural, as any team or group of teams, or any player or group of players, identified with AND/OR logic, within a set of cricket matches, teams, players, or players within teams (including within or representative of a tournament, series, or season), or by distinguishing characteristics, and may also take the forms "Any" or "None."

<above/below/exactly/at least/between>: <above/below/exactly/at least/between> refers to comparison operators. "Above" means greater than (>), "below" means less than (<), "exactly" means equal to (=), "at least" means greater than or equal to (≥), and "between" means within an inclusive range (≥ lower bound and ≤ upper bound) unless otherwise specified.

<count>: <count> refers to a numerical value specified by the Exchange. <count> may take the form of, but is not limited to, integer or non-integer values (e.g., 4, 4.5, or 0). <count> may also take the form(s) of a cumulative or discrete value, a range, or a threshold expressed as "at least X," "no more than Y," or "between X and Y."

<stat>: <stat> refers to an official statistic specified by the Exchange, which may include but is not limited to: runs scored, wickets taken, catches, stumpings, run-outs, boundaries (fours), sixes, dot balls, extras, wides, no-balls, byes, leg-byes, balls faced, overs bowled, maidens, strike rate, economy rate, and any combined or compound statistics (e.g., runs + boundaries, wickets + catches). <stat> may be identified in the singular (e.g., runs), or in the multiple using AND/OR operations (whereby "AND" will be understood to refer to cumulative numerical total, and "OR" to the highest count number specified).

<time period>: <time period> refers to a segment of <cricket match> or the tournament at which <cricket match> is played, specified by the Exchange. <time period> may take, but is not limited to, the following forms:

- Entire match, which refers to the complete match including all innings and any Super Over or tiebreaker required to produce a result
- A specific innings (e.g., first innings, second innings, or both innings combined)
- A powerplay period (e.g., Powerplay 1 overs 1-6, Powerplay 2 overs 7-15, Powerplay 3 overs 16-20 in T20 format)
- A specific set of overs (e.g., overs 1-6, overs 7-10, death overs 16-20)
- Super Over only

- A specific phase of play (e.g., batting first innings only, bowling second innings only)
- The total career of <entity>
- A given segment or subsection of a competition, series, or tournament, or the competition in its entirety

<time period> may also take the forms of any segment in a set range, refer in the singular or the multiple, by distinguishing characteristics (e.g., any match in the group stage), "Any" or "None." Where not specified otherwise, <time period> shall be understood to refer to the full match including any Super Over.

<cricket match>: <cricket match> refers to an officially scheduled contest between two teams as recognized by the International Cricket Council (ICC) or the governing body of the relevant competition (e.g., national cricket boards, franchise leagues such as IPL, BBL, or CPL) and specified by the Exchange. <cricket match> may be defined by the names of the teams involved, by the date of the match, by the format of the match (T20, One Day International, Test), by the stage of the tournament (e.g., group stage, Super 8, semi-final, final), as any cricket match within a set of cricket matches (including within or representative of a tournament, series, or season), or by distinguishing characteristics. <cricket match> may also take the forms "Any" or "None."

Payout Criterion: The Payout Criterion for the Contract encompasses the Expiration Values that the number of <stat> recorded by <entity> in <time period> of <cricket match> is <above/below/exactly/at least/between> <count>.

Additional clarification(s) regarding statistics:

- Statistics are considered final at the conclusion of <cricket match>, including any Super Over or tiebreaker if applicable. Corrections made afterwards will not affect the value of the Contract.
- If <time period> is specified in the Contract Title (e.g., "First to 50 runs in the Powerplay"), then <stat> must be achieved within that segment only; statistics accumulated outside of <time period> do not count.
- For bowling statistics, a bowler must deliver at least one legal ball in <time period> for their statistics in that period to be counted.
- For batting statistics, a batter must face at least one legal delivery in <time period> for their statistics in that period to be counted.

Additional clarification(s) regarding match outcomes:

- If <cricket match> is cancelled prior to scheduled commencement, all markets on <cricket match> will resolve to the last fair price as determined by the Exchange in its sole discretion.
- If <cricket match> is abandoned after the start of play and no official result is declared by the governing body (including via the Duckworth-Lewis-Stern method), all markets except for statistics already definitively achieved (which will resolve on the basis of available data) will resolve to the last fair price as determined by the Exchange in its sole discretion.
- If <cricket match> is shortened due to weather or other factors and an official result is declared via the Duckworth-Lewis-Stern (DLS) method or any other ICC-approved method, match winner markets will resolve based on the official result, but individual statistical markets will resolve based on actual statistics accumulated, not projected or adjusted figures.
- If <cricket match> is delayed for 48 hours or less from its original scheduled start time, all markets on <cricket match> will remain open.
- If <cricket match> is delayed for more than 48 hours from its original scheduled start time, all markets on <cricket match> will resolve to the last fair price as determined by the Exchange in its sole discretion.
- If a given <entity> or player withdraws prior to the commencement of <cricket match> or is not named in the playing XI, the markets on <entity> or player performance in <cricket match> will resolve to the last fair price as determined by the Exchange in its sole discretion.
- If a given <entity> or player retires hurt, is injured, or otherwise leaves the field during <cricket match> but has participated for at least one legal delivery (faced or bowled), the markets on <entity> or player will settle based on the end-of-match statistics.
- If a given <entity> or player is disqualified, sanctioned, or has statistics annulled following <cricket match>, the

markets on <entity> or player will settle based on the statistics as recorded at the conclusion of <cricket match>, prior to any post-match disciplinary action.

- If data for the results of <cricket match> is delayed or unavailable, the Exchange may wait up to 24 hours for it to become available. If, after 24 hours, the data remains unavailable, all markets on <cricket match> that cannot be settled due to missing data will resolve to the last fair price as determined by the Exchange in its sole discretion.
- If there is a change to the format of <cricket match> that materially affects markets on <cricket match> (e.g., reduction in overs due to weather), the affected markets may be resolved based on actual statistics accumulated, or to the last fair price as determined by the Exchange in its sole discretion.
- If a tournament or series is truncated mid-competition, all cumulative statistical markets deemed to be affected by such truncation may be resolved to the last fair price as determined in the sole discretion of the Exchange.

Examples that would resolve the market to Yes (for a market titled "Will <entity> score at least 30 runs in <cricket match>?"):

- <entity> scores exactly 30 runs in the match
- <entity> scores 45 runs in the match
- <entity> scores 30 runs in the first innings and does not bat in the second innings

Examples that would NOT resolve the market to Yes:

- <entity> scores 29 runs in the match
- <entity> is not named in the playing XI and does not bat
- <entity> is named in the playing XI but the match is abandoned before play begins (would resolve to last fair price)

Minimum Tick: The Minimum Tick size for the Contract shall be \$0.01.

Position Accountability Level: The Position Accountability Level for the Contract shall be \$25,000 per strike, per Member.

Last Trading Date: The Last Trading Date of the Contract will be the same as the Expiration Date. The Last Trading Time will be the same as the Expiration time.

Settlement Date: The Settlement Date of the Contract shall be no later than the day after the Expiration Date, unless the Market Outcome is under review pursuant to Rule 7.1.

Expiration Date: The latest Expiration Date of the Contract shall be the third day following <cricket match>. If an event described in the Payout Criterion occurs, expiration will be moved to an earlier date and time in accordance with Rule 7.2.

Expiration time: The Expiration time of the Contract shall be 10:00 AM ET.

Settlement Value: The Settlement Value for this Contract is \$1.00.

Expiration Value: The Expiration Value is the value of the Underlying as documented by the Source Agency on the Expiration Date at the Expiration time.

Contingencies: Before Settlement, Kalshi may, at its sole discretion, initiate the Market Outcome Review Process pursuant to Rule 7.1 of the Rulebook. If an Expiration Value cannot be determined on the Expiration Date, Kalshi has the right to determine payouts pursuant to Rule 7.1 in the Rulebook.

APPENDIX B - TRADING PROHIBITIONS

In addition to the general prohibition against trading on material nonpublic information, the Exchange will institute additional prohibitions for trading the contract. Persons under 18 years of age are not permitted to create Kalshi accounts. The following individuals will be prohibited from trading:

- Current and former players, coaches, support staff, and team management of the teams, boards, franchises, or organization(s) participating in or governing <cricket match>.
 - For domestic leagues, franchise tournaments, or where otherwise appropriate (as identified by the Exchange), this applies to current and former players/coaches/support staff of the specific teams in <cricket match> rather than the league or governing body as a whole.
- Paid employees of the governing board, league, or franchise owners participating in <cricket match>.
- Team selectors and selection committee members with knowledge of squad or playing XI decisions for <cricket match> that have not been publicly disclosed.
- Match sponsors, tournament organizers, and board executives with material decision-making authority.
- Pitch curators, groundskeepers, and grounds crew with knowledge of pitch preparation decisions (grass length, soil composition, moisture content, rolling schedules, surface characteristics) for <cricket match> that have not been publicly disclosed.
- On-field umpires, third umpires, fourth umpires, and match referees assigned to <cricket match>.
- Employees and contractors of the official statistics, ball-tracking, or review technology providers for <cricket match> (e.g., Hawk-Eye operators, UltraEdge technicians, Hot Spot operators, scoring officials) who have access to real-time or pre-publication statistical or tracking data.
- Television and media production personnel with non-public access to real-time scoring data, player tracking data, or statistical information prior to public broadcast.
- Medical personnel, physiotherapists, and team doctors retained by the governing body of <cricket match> or by teams participating in <cricket match> who have non-public information regarding player health, injury status, fitness assessments, or likelihood of withdrawal that has not been publicly disclosed.
- Anti-corruption and integrity officers assigned to or employed by the governing body of <cricket match> who have non-public information regarding player conduct, investigations, or match-related integrity concerns.

- Weather consultants or meteorologists contracted by the governing body of <cricket match> with non-public information regarding weather-related scheduling, rain delays, or abandonment decisions.
- Toss officials or personnel present at the toss with knowledge of toss results or captain decisions prior to public announcement.
- Net bowlers, practice squad members, and training personnel with non-public knowledge of team strategies, player fitness, or playing XI decisions for <cricket match>.
- Household members and immediate family of all above.

These prohibitions apply to the appropriate values of <cricket match>. For example, former players of the Indian Premier League are not necessarily prohibited from trading on iterations of the Contract related to the Big Bash League, unless they are part of any other group listed for that tournament. Similarly, employees of the Board of Control for Cricket in India (BCCI) are not necessarily prohibited from trading on iterations of the Contract related to matches governed exclusively by Cricket Australia, unless they are part of any other group listed for that match.
